La Secretaría del Organismo Internacional de Energía Atómica (OIEA) saluda a los Estados Miembros del OIEA y tiene el honor de señalar a su atención la celebración de la **Reunión Técnica sobre Redes de Enseñanza** (denominada en adelante el “evento”), que tendrá lugar en la Sede del OIEA en Viena (Austria) del **2 al 6 de agosto de 2021**.

Además, se podrá participar en el evento de forma virtual a través de Cisco Webex.

La finalidad del evento es promover la cooperación y el intercambio de prácticas óptimas entre redes de enseñanza en el ámbito nuclear, prestando especial atención a las prácticas óptimas asociadas a la tecnología digital.

En la reseña informativa adjunta se ofrecen más detalles sobre el evento.

El evento se celebrará en inglés.

Se invita a los Estados Miembros a designar una o más personas para que participen en este evento en representación de su Gobierno y se los alienta encarecidamente a que seleccionen con ese fin a mujeres cualificadas.

Por lo general, el OIEA no está en condiciones de sufragar los gastos de viaje ni de otra índole de los participantes en el evento. No obstante, dispone de fondos limitados para ayudar a cubrir los gastos de asistencia de determinados participantes. Esa ayuda puede ofrecerse normalmente, previa solicitud expresa, a un participante por país siempre que, en opinión del OIEA, la persona para la que se solicite pueda hacer una contribución importante al evento. La solicitud de apoyo financiero debe presentarse en el momento de la designación de los participantes mediante el formulario de solicitud de subvención adjunto (Formulario C).

Cabe señalar que el OIEA no paga ninguna indemnización por daños o pérdida de efectos personales. Tampoco proporciona seguro médico a los participantes en eventos del OIEA. Por lo tanto, se recomienda que estas personas adopten las medidas necesarias para contratar por su cuenta un seguro privado. No obstante, el OIEA cubrirá mediante un seguro los accidentes y las enfermedades claramente relacionados con los servicios prestados al OIEA.

Las designaciones deben presentarse al OIEA por conducto de la autoridad nacional competente (el Ministerio de Relaciones Exteriores, la Misión Permanente ante el OIEA o la Autoridad Nacional de Energía Atómica), a más tardar el **1 de junio de 2021**, por medio del formulario de participación adjunto (Formulario A). Una vez recibidas las designaciones oficiales, el Secretario Científico del evento contactará directamente a los participantes en relación con otras cuestiones de organización, como los detalles del viaje, según proceda.

Information Sheet

Introduction

The IAEA aids Member States in the provision of sustainable nuclear education and training in all areas of the peaceful use of nuclear energy, by supporting the activities of the regional education networks.

Networking education through regional and interregional cooperation provides a more effective use of educational resources. Good practices, experiences and lessons learned can be shared through regional and interregional cooperation with the IAEA promoting worldwide partnerships of nuclear education and training institutions.

The IAEA has directly fostered regional educational networks in Asia, Africa, the Latin-American and Caribbean Region, and in Eastern Europe and Central Asia. The collaboration within and among educational networks contributes to the promotion, management and preservation of nuclear knowledge and helps to ensure that talented and qualified human resources are available for the safe and sustainable use of nuclear technology. The networks also promote cooperation between academia, government and industry.

The IAEA has supported the educational networks through technical cooperation projects and meetings to exchange information, experiences and implement actions to address common issues in the area of nuclear education.

This year's event will promote nuclear knowledge management (NKM) services and resources and promote an exchange of best practices. In particular, participants will have an opportunity to discuss the NKM Digital Hub and how it can be used to support educational network activities. Participants will have the opportunity to provide best practices associated with digital technology as well as to provide feedback and recommendations on how the Hub is currently used and how to optimize its function and use.

During the meeting activities undertaken and results achieved by regional and national educational networks will be reviewed and opportunities for enhancing collaboration discussed. Participants will be encouraged to share outreach materials and strategies.

Objectives

The purpose of the event is to foster cooperation and the sharing of best practices between nuclear education networks, with a specific focus on best practices associated with digital technology.

The objectives are to:

- Share and build on international experience with networking nuclear education to present activities undertaken by the nuclear education networks and participating institutions on matters of common interest and related best practices;
- Present outreach material and strategies adopted by participating institutions;
- Discuss common challenges faced by the educational networks and institutions for nuclear education and how they may be overcome;
- Discuss potential ways the NKM Digital Hub can be used for individual and collaborative projects.

Target Audience

The event is targeted at:

- Nuclear education providers;
- National and regional networks, agencies or bodies that support nuclear education.

Working Language

The working language will be English.

Expected Outputs

The expected outputs of the event are:

- a) Recommendations on the use of the NKM Digital Hub to promote and facilitate its use;
- b) Further examples of outreach activities and good practices that can be included on the NKM Digital Hub.

Application Procedure

All persons wishing to participate in the event have to be designated by an IAEA Member State or should be members of organizations that have been invited to attend.

In order to be designated by an IAEA Member State, participants are requested to send the **Participation Form (Form A)** to their competent national authority (e.g. Ministry of Foreign Affairs, Permanent Mission to the IAEA or National Atomic Energy Authority) for onward transmission to the IAEA by **1 June 2021**. Participants who are members of an organization invited to attend are requested to send the Participation Form (Form A) through their organization to the IAEA by above deadline.

Selected participants will be informed in due course on the procedures to be followed with regard to administrative and technical matters.

Papers and Presentations

No formal papers will be required for this event. However, participants will be expected to:

- Give a summary presentation on current processes, standards and experiences, related to networks;
- Describe outreach strategies and contribute any outreach materials where possible;
- Actively participate in dialogue at the event;
- Provide any other input useful to the IAEA's activities on this topic.

Expenditures and Grants

No registration fee is charged to participants.

The IAEA is generally not in a position to bear the travel and other costs of participants in the event. The IAEA has, however, limited funds at its disposal to help meet the cost of attendance of certain participants. Upon specific request, such assistance may be offered to normally one participant per country, provided that, in the IAEA's view, the participant will make an important contribution to the event.

The application for financial support should be made using the Grant Application Form (Form C), which has to be stamped, signed and submitted by the competent national authority to the IAEA together with the Participation Form (Form A) by Designation Deadline.

Venue

The event will be held at the Vienna International Centre (VIC), where the IAEA's Headquarters are located. The event will take place in Press room, M Building, and will start at 9.30 a.m. on Tuesday, 2 August 2021 and end at 3.30 p.m. on Friday, 6 August 2021. Participants must make their own travel and accommodation arrangements.

General information on the VIC and other practical details, such as a list of hotels offering a reduced rate for IAEA participants, are listed on the following IAEA web page: <http://www-pub.iaea.org/iaeaevents/GeneralInfo/Guide/VIC>.

Participants are advised to arrive at Checkpoint 1/Gate 1 of the VIC one hour before the start of the event on the first day in order to allow for timely registration. Participants will need to present an official photo identification document in order to be admitted to the VIC premises.

Visas

Participants who require a visa to enter Austria should submit the necessary application to the nearest diplomatic or consular representative of Austria at least four weeks before they travel to Austria. Since Austria is a Schengen State, persons requiring a visa will have to apply for a Schengen visa. In States where Austria has no diplomatic mission, visas can be obtained from the consular authority of a Schengen Partner State representing Austria in the country in question.
