ARTICLE 1

General Provisions

1. This Annex specifies the obligations of Norway regarding the application of customs duties on imports.
2. For the purposes of the Agreement, Norway shall apply its customs classification system for imported goods, at eight-digit level, which shall be based on the HS in its 2022 version or any subsequent amendment thereto approved by the Parties.
3. Norway shall reduce or eliminate customs duties on imports on goods originating in MERCOSUR in accordance with the schedule of tariff commitments set out in this Annex.
4. At the time of importation, the lower duty between the most-favoured-nation applied rate and the applicable customs duty on imports set out in this Annex shall prevail.
5. For the purposes of the bilateral tariff-rate quotas (TRQs) set out in this Annex, if the entry into force of the Agreement corresponds to a date after 1 January and before 31 December, the in-quota quantity shall be pro-rated on a proportional basis for the remainder of that calendar year. Thereafter, Norway shall make available the entire yearly quota quantity established in accordance with the schedule of tariff commitments set out in this Annex to quota applicants throughout the course of the calendar year.

ARTICLE 2

Specific Provisions

1. The following terms and conditions shall apply to tariff concessions granted by Norway in accordance with this Annex:
 - (a) Norway shall apply customs duties on imports on goods (“BAP” (Basic Agricultural Products) and “PAP” (Processed Agricultural Products)) originating in MERCOSUR as set out in column 4a or 4b.
 - (b) For goods originating in MERCOSUR categorized as PAP in column 3, the following provisions shall apply:

- (i) in order to take into account the differences in the cost of the agricultural raw materials incorporated into the products identified as “PAP”, the Agreement does not preclude the levying, upon import, of a duty;
 - (ii) duties levied upon import shall be based on, but shall not exceed, the difference between the domestic price and the world market price of the agricultural raw materials incorporated into the products concerned;
 - (iii) subject to the provisions laid down in subparagraphs (b)(i) and (b)(ii), Norway shall accord to goods originating in MERCOSUR categorised as “PAP” the same concessions as those given to the European Union (EU) ¹ as of 1 January 2018. If the concessions for these goods are changed in the agreement (Protocol 3 to the Agreement on the European Economic Area) between Norway and the EU, MERCOSUR will simultaneously be accorded the same concessions; and
 - (iv) Norway shall publish the applicable import duties for PAP on the website of the EFTA Secretariat in the English language.

- (c) For goods originating in MERCOSUR indicated as “Excluded” in column 4a and column 4b, no commitments related to customs duties shall be granted by Norway.
 - (d) Norway shall, based on an end-use criteria, accord duty-free market access to both fish-feed and raw materials for making fish-feed, originating in MERCOSUR.
 - (e) The classification of goods shall be that set out in the tariff nomenclature of Norway, at a level of eight- (8) digits, based on the Harmonized Commodity Description and Coding System in its 2022 version or any subsequent amendment thereto approved by the Parties.
